The Addendum consists of the following changes:

**1. ADMINISTRATIVE ITEMS; Bidding Documents:**

- 1.1. CHANGE: Change the bid time and date in the “Notice Inviting Bids”, first paragraph, to 1:00 PM, February 7, 2023.
- 1.2. CHANGE: Change the time and date by which Pre-bid clarification Requests shall be filed in the “Instruction to Bidders, Section 9, Interpretation of Plans and Documents/Pre-Bid Clarification” to 2:00 PM, January 16, 2023.

**2. ANSWERS TO PRE-BID CLARIFICATION REQUESTS**

**2.1. RFC No.2**

- 2.1.1. Question: What is the estimated project duration for the Music & Wray Theater Renovation Project? Start – (Month / Year) – Finish – (Month / Year)
- 2.1.2. Answer: Substantial Completion (SC) is as referenced in Article 2 of the Agreement. SC is the effective date of the Notice to Proceed plus 547 calendar days. Final Completion is the effective date of the Notice to Proceed plus 609 calendar days. The NTP is forecasted to be issued in the 2<sup>nd</sup> Quarter of 2023.

**2.2. RFC No.3**

- 2.2.1. Question: There is no Glazing Specification in Division 8.
- 2.2.2. Answer: The “Glazing” Specification is Section 08 80 00 and it is included in the Project Manual.

**2.3. RFC No. 4**

2.3.1. Question: Invitation for Bids shows bids are due on January 17, 2023 @ 10:00 AM. However, Bid Documents shows bids are due on January 17, 2023 @ 1:00 pm. Please advise what time are bids due.

2.3.2. Answer: The bid time and date has been changed under this Addendum No. 2. The new bid time and date is 1:00 PM, February 7, 2023.
