9th-12th Grade Petition For Concurrent Enrollment

Please read the following information carefully and complete the attached 9th-12th Grade Petition For Concurrent Enrollment.

Rio Hondo College is a two-year community college. We have had for several years, an open agreement with local high school districts to enroll high school students in college classes.

The Community College educational environment is geared toward adult students. This is true in both lecture/discussion classes as well as skills/performance classes. Lecture/discussion courses are not always appropriate for younger students due to the nature of topics discussed and the language that may be used.

POLICY

A maximum of seven (7) credits or two (2) (non-remedial) classes per semester may be taken. However, we realize that academically advanced students younger than college level may wish to take advanced college level courses. We allow enrollment of such students based on criteria established.

We will try to serve high school students in the following areas:

- Classes that are not currently offered in their school system
- Due to scheduling conflicts in the high school schedule
- Classes that are advanced beyond the level of courses at the high school level
- Classes that will help the student complete graduation from the high school

****Students in grades K-8 are required to submit an official IQ test score 150 or greater. Ref: Title V 52201(b)**

ENROLLMENT REQUIREMENTS

In order for high school age students to enroll in the above areas, the following is required:

- Students must complete and sign the petition on the reverse side of this form
- This petition must contain the parent's **AND** Principal or designee's signature indicating approval for enrolling in classes at the college
- Home School students must provide verification of satisfactory completion of courses instructed at the home school and obtain signature from the District they have been released from
- All students must complete the appropriate Rio Hondo College application and registration forms and are required to complete the Rio Hondo College placement/assessment exam
- All pre-requisites must be met or cleared prior to registration
- Submissions of this petition does **NOT** constitute official enrollment of classes. After submission, you must still register for class(es) that have been approved for official enrollment.
