

# Rio Hondo Math Academy

## Information & Application Process

Before returning this petition, it is important to read the following information and requirements below.

### General Information

1. Rio Hondo College provides mathematics courses for middle and high school students wishing to complete a year of mathematics during the summer.
2. Record of math academy course(s) will not appear on the Rio Hondo student's credit transcript. Students who drop the class will not receive a passing grade from Rio Hondo. Rio Hondo will only provide a Pass or No Pass on noncredit transcripts. Each high school participating in the Math Academy accepts a different passing grade(s) earned during the summer.
3. Attendance on the first day of class is mandatory. Students with excess absenteeism will not earn a passing grade. It is the students' responsibility to know the attendance standards of their course. Students with 3 or more absences will be dropped from the class. Students not attending class meetings may lose their seat to another student.
4. Students are expected to participate in all course activities, including field trips, if applicable.
5. Homework, classwork, group assignments and class presentations will be expected. These activities will be required of all students.
6. Students must abide by the Student Code of Conduct.

### Application Process

#### Step 1 – Complete this Form

- Complete the front of this form with your information. Obtain your parent/guardian signature and return it to Rio Hondo College Continuing Education, room 901 at **9426 Marjorie Street, Pico Rivera, CA 90660** or to your middle school's Front Office. You will receive an email from the Math Academy administration informing you of your enrollment status and class information prior to the first day of class.

#### Step 2 – Attend Classes After Enrollment Verification

- Make every effort to attend all of your classes during the summer. Notify your instructor if you are unable to attend class and make the necessary arrangements to make up the work missed.
