

# Information & Application Process

Before returning this petition, it is important to read the following information and requirements below.

## General Information

1. Río Hondo College provides mathematics courses for high school students wishing to complete a year of mathematics during the summer.
2. Record of math academy course(s) will not appear on the Río Hondo student's credit transcript. Students who drop the class will not receive a passing grade from Río Hondo. Río Hondo will only provide a Pass or No Pass on noncredit transcripts. El Rancho Unified School District (ERUSD) will only accept a "C" as a passing grade during the summer.
3. Attendance on the first day of class is mandatory. Students with excess absenteeism will not earn a passing grade. It is the students' responsibility to know the attendance standards. Students with 3 or more absences will be dropped from the class. Students not attending class meetings may lose their seat to another student.
4. Students are expected to participate in all course activities, including field trips, if applicable.
5. Homework, classwork, group assignments and class presentations will be expected. These activities will be required of all students. After-school tutoring for additional support is strongly encouraged.
6. Students must abide by the Student Code of Conduct, including the electronic device and dress code policy. Students who violate these policies will be subject to the Student Disciplinary Policy and may be removed from the program. All disciplinary incidents become part of the student's permanent records / history.
